DIRECTOR'S REPORT: Sue Swithin presented the Director's report as it appears in the board packet. Progress of programs: Softball is running, and Park District offered a free week of fitness. The Go Fund Me page for the Tennis Court additions is up and running. Sue Swithin spoke with Rick Olson, Mayor of City of Sandwich, regarding the city putting in the path at Harvey Creek and discussed the deed at Gletty Park. Sue Swithin received email from Rick Olson giving her an ok to talk with their lawyers about the Gletty Park deed. Donut Dash Race is on schedule and should have enough staff and volunteers.

COMMITTEE REPORTS:

RECREATION: Discussed Girls Softball program and how it is doing financially. The program is bringing in a mid-20% profit. Girls Softball program has a good number of participants. Garland will be interviewing tennis instructors to get more tennis programs for the youth, adults, leagues and various groups. Discussed the Go Fund Me page and it is up and running for the Tennis Courts. Sue met with 2 parent reps from Girls Softball league on Monday evening. They are asking for field improvements, they would like to try a different type of ball mix for the fields to see if it would drain better and have less rainout games. Steve Wolf asked about the kayak/canoes, Diane Scents mentioned this will be on the December agenda for Recreation. Diane Scents would like Candace to attend the next meeting and find out what are the specific plans for the kayak/canoes.

PARKS: The Boy Scouts will be doing a rocket launch on October 21, at Milestone Park. The Boy Scouts will also be planting 2 trees that will be donated by Winding Creek Nursery.

FINANCE: Next meeting is November 8, 2017 at 5:30 pm. To review the 6 month budget, the Tax Levy Ordinance, Final Audit and AFR if available.

CAPITAL DEVELOPMENT: Committee did not meet.

RISK MANAGEMENT & LAW AND ORDER/SAFTEY: Committee did not meet.

PERSONNEL: Committee did not meet.

UNFINISHED BUSINESS: Go Fund Me Page is up and running. Collected \$25. The Final Audit was not ready so it will be tabled until next board meeting on November 8, 2017.

NEW BUSINESS: Sue Swithin asked if she and Bill Novicki could attend one day of the upcoming IParks conference so they can stay current with their Continuing Education Units (CEU) even though there is no money in the budget for this conference. Board agreed this would be beneficial for the organization.

A request to have Lisa Seeman become the IMRF Authorized Agent for Sandwich Park District was made so she can attend the training in the next few weeks.

A motion was made by Roberta Troeger and seconded by Diane Scents to appoint Lisa Seeman as the IMRF Authorized Agent.

A draft of the Tax Levy Ordinance was presented to the Board to review, it will be discussed at the next Finance meeting in November and presented at the next Board Meeting for approval.

Sue Swithin asked if the park district would pay for Bill Novicki to take the CPRP test. Upon Bill Novicki passing the exam, the board agreed to reimburse him for the CPRP test expense. The CPRP test costs about \$200. Once he passes he would need to be a NRPA which would then cost \$165 a year to be a member. Sue Swithin also asked to increase Bill Novicki's pay if he passes, no decision was made at this time regarding increase in pay.

There being no further business, a motion was made by Roberta Troeger and seconded by Steve Wolf to adjourn the meeting at 7:18 pm. The next regular meeting will be held on November 8, 2017 at 6:30 pm.
