PARK DISTRICT IN THE COUNTIES OF DEKALB AND KENDALL AND STATE  
OF ILLINOIS

The estimated total Property taxes to be levied for 2020 are \$ 549,860.00. This represents a 4.69% increase over the previous year.

Making the aggregate sum of Five Hundred Forty-Nine Thousand Eight Hundred Sixty Dollars (549,860.00) to be raised by taxation and levied on all the taxable property in said Park District in order to meet and defray all the necessary expenses and liabilities of the Park District as required by statute or voted by the people in accordance with law.

That the Secretary of the Sandwich Park District shall file with County Clerks of the Counties of DeKalb and Kendall, State of Illinois, a certified copy of the Ordinance, no later than the third Tuesday in December, 2020.

This Ordinance shall be in full force and effect from and after its passage and approval.
