<u>Investment Options</u>: Discussed at the finance committee meeting was the opportunity to invest part of our funds into a certificate of deposit. First National Bank had an offer of 1.0% for any term cod or money market account. The bank agreed to update our current interest rate of .05% to 1.0% on both our checking account and money market. Will contact bank to discuss the FDIC insured coverage to determine if we will invest at this time.

<u>KSRA Agreement:</u> Kishwaukee Special Recreation Association has presented an updated agreement with a term from January 1, 2020 to December 31, 2025. The Sandwich Park District designated member is Interim Director, Bill Novicki.

A motion was made by Roberta Troeger and seconded by Bill Clemons to approve the Kishwaukee Special Recreation Association (KSRA) agreement with the contingency that the term of agreement be changed to 3 years, therefore the term would be January 1, 2020 to December 31, 2023.

<u>Sexual Harassment Prevention Training</u>: The State of Illinois has passed a law that every employer in the State of Illinois is required to provide employees, commissioners and independent contractor's with sexual harassment prevention training by December 31, 2020 and again once every year. A certificate of completion will be kept on file. Anyone who has already taken the training this year will need to provide the district with a copy of their certification.

<u>COVID-19 Policy</u>: A copy of a draft Sandwich Park District Coronavirus (COVID-19) policy was included in the board packet. The policy is also being reviewed by our attorney for proper guidelines and legal clarification. Discussed possible changes and updates to the policy. The board has

encouraged Interim Director, Bill Novicki to talk with the staff to discuss current guidelines and comfort level. Some employees are not equipped to work from home and some job duties do not warrant the ability to work from home if they were to be quarantined. A review of employee computers/laptops will be needed and may be added to the replacement plan.

<u>Property Tax Appeal</u>: A Property Tax Assessment Appeal was received from the Kendall County Board of Review for Plano Molding Co. We have 10 days from the date received to submit our intentions to intervene, and 14 days to submit supporting evidence.
