PARK DISTRICT IN THE COUNTIES OF DEKALB AND KENDALL AND STATE  
OF ILLINOIS

The estimated total Property taxes to be levied for 2021 are \$ 568,150.00. This represents a 4.79% increase over the previous year.



This Ordinance shall be in full force and effect from and after its passage and approval.


