DIRECTOR’S REPORT: A copy of the Director’s report was made available to all Board Members. Executive Director, Bill Novicki noted the Harvest Moon Hayrides and Halloween Egg Hunt will be coming up on October 30th and volunteers will be needed for the event. The Daily Operations Manual is being updated; Board would like to review final draft before implementing. Maintenance department rented a stump grinder and was able to remove 50 stumps and noted that additional trees will need to be removed. The ADA water fountain at Veteran’s Park is currently being installed with the help of the City of Sandwich through a county grant; some bushes had to be removed and spring restoration is being planned.

RECREATION: None

BUILDINGS & GROUNDS: Committee Chair, Clinton Harris reported that a meeting was held this week and discussed the following:

- Basketball Programs-Some logistics need to be worked out yet such as the jersey’s worn and school mitigations for Covid-19.
- Basketball Timer- Payment to basketball timers was reviewed and it was suggested to pay the Basketball Timers \$10.00 per game beginning this season. It was recommended to put this type of information in the Operations Manual.
- Soccer Referee and Basketball Referee- Payments may need to be increased in order to compete with other areas. It was suggested to possibly have a separate coordinator for the soccer program.

Milestone Parking Lot Project: Geneva Construction has completed paving the Milestone Parking Lot and that electrical work has begun and the new light poles will be installed soon. Tebrugge Engineer reported that the contractor had gone out a little wider on the pavement than the scope had indicated; will inform us if any additional details. Banners have been made to place on the light poles.

ADA Project Update: Executive Director, Bill Novicki reported that the ADA improvements have been completed at Ernest Memorial Park, Patriot's Park had some engineering issues in the plans that the contractor had pointed out prior to beginning. Milestone Park improvements have begun this week and should be completed in a couple of weeks. It was noted that communication with this contractor has been very well received and we have been pleased with their work. It was suggested to have a list created of vendors used and for which projects with notations to refer to when looking at future capital planning projects.
